ADDENDUM # 4

To prospective Proposers on RFP # 600000138, entitled “Operate, Manage and Maintain the On-Airport Bus Fleet at the Port Authority of New York & New Jersey’s Newark Liberty International Airport”:

- RFP due January 12, 2021 at 2:00 PM

A. CHANGES/MODIFICATIONS:

- I. Section 31, entitled “Vehicle Maintenance”, of Attachment B, add at the end “All in-service buses shall be cleaned once per day. In every vehicle, both the passenger and driver high touch areas must be disinfected. High touch areas are handrails/ holds, armrests, steering wheels, dashboards, lavatory surfaces, buttons, handles, switches, window rails, fareboxes, etc. with a disinfectant approved by the CDC.”
- II. Section 37, entitled “Job Requirements”, paragraph 3, of Attachment B, deleted in its entirety and replace with the following: “The Contractor shall provide a Management Representative and Operations Manager to serve EWR. The Contractor shall provide the services of a Maintenance Manager, and a Safety and Training Supervisor as agreed to by the Port Authority in the Award Letter. The Contractor shall ensure Field Supervisor physical presence at EWR on a twenty-four (24) hour per day/seven (7) day per week basis, and a Contractor Management Representative must be accessible and available twenty-four (24) hours a day. An individual acceptable to the Manager must cover all absences of all such personnel or Liquidated Damages may be imposed as set forth in the Section 12 of Attachment B t entitled "Liquidated Damages". Contract Management staff and Field Supervisors are not permitted to leave the Facility during their scheduled workday without the express permission of the Manager.”
- III. Section 45, “Space Provided to the Contractor”, of Attachment B paragraph iv, delete the following sentence, “Maintain the bus wash system and replenish the system with approved bus detergent and other supplies.”

- IV. Replace Exhibit 2B with the attached revised Exhibit 2B, entitled “Cost Proposal Form”, is modified to show a breakdown of estimated hours per bus requirement.
- V. Replace Exhibit 4 with the attached revised Exhibit 4, entitled, “Daily Scheduled Hours”, updated to reflect the current reduced bus schedule due to COVID-19.
- VI. Replace Exhibit 10 with the attached revised Exhibit 10, entitled “EWR Bus Inventory”, updated to reflect current bus mileage.
- VII. Replace Exhibit 11 with the attached revised Exhibit 11, entitled “List of Available Warrantees”, to include the available warrantees on the Proterra buses.
- VIII. Replace Exhibit 13B with the attached revised Exhibit 13B, entitled “Shuttle Bus Routes”, which is expected to be effective early/mid 2022.

The furnishing of such information by the Port Authority shall not create or be deemed to create any obligation or liability upon it for any reason whatsoever and each Respondent, by submitting its Response, expressly agrees that it has not relied upon the foregoing information, and that it shall not hold the Port Authority liable or responsible therefore in any manner whatsoever. Accordingly, nothing contained herein and no representation, statement or promise, of the Port Authority, its Commissioners, officers, agents, representatives, or employees, oral or in writing, shall impair or limit the effect of the warranties of the Respondent required by this Response or Contract and the Respondent agrees that it shall not hold the Port Authority liable or responsible therefore in any manner whatsoever.

1. What is the current hourly rate for this service?
 - A. Information relating to the current contract does not necessarily reflect the particular scope of work for the contract to be awarded as a result of this solicitation. Accordingly, you should submit a proposal, including a mutually

beneficial financial proposal, in response to the requirements of this solicitation.

2. Please provide the current provider's performance related to the Performance Standards for the services as listed in the RFP for the past 12 months.
 - A. This information is not available.
3. The RFP lists 35 buses in the inventory. Could a fleet replacement schedule be provided for the 23 Orion buses and when they are expected to be replaced?
 - A. At the present time, there is no set schedule for replacing the Orion buses.
4. Please confirm the pricing for the first three years is not subject to escalation and fixed for the agreement's entire base term.
 - A. Please see Section 10, entitled "Escalation Term and Option Years" of Attachment B.
5. Please confirm that option years are subject to CPI escalation only and fixed every year for each option.
 - A. Please see Section 10, entitled "Escalation Term and Option Years" of Attachment B.
6. Refurbishments of buses can be quite extensive and cost in excess of \$100,000 depending upon the final work scope. This section states, Labor shall be compensated at the unit price inserted on the Cost Proposal Form by the Contractor. Will parts and materials be the sole responsibility of the Contractor?
 - A. Please refer to Section 19, entitled "Refurbishment of Buses" of Attachment B.
7. The RFP states, Contractor shall provide the Additional Vehicles, but such request for Additional Vehicles shall never require more than five (5) Additional Vehicles at any one time. Are these vehicles currently dedicated? If so, what types of vehicles are required for this requirement?
 - A. Additional vehicles refer to transit-style buses that are similar to the existing fleet provided under this Contract, but which are not provided by the Port Authority of NY & NJ. There are currently no additional vehicles dedicated in the current contract.
8. Could the price pages be provided in Excel format?
 - A. No.
9. Is there currently a Collective Bargaining Agreement in place? If so, please provide a copy of the current CBA or a contact at the local union.
 - A. To the best of the Port Authority's knowledge and belief, the Retail, Wholesale and Department Store Union, Local 108, Maplewood, NJ represent the bus drivers under the current contract.
10. Please provide the current inventory of spare parts and the estimated costs of acquisition.

- A. Please see Exhibit 12 for the spare parts list. Any sale of inventory not purchased by the Port Authority of NY & NJ and provided to the current contractor will be a transaction between the existing contractor and the selected new Contractor.
11. The RFP states, each off-airport location otherwise permitted by the Port Authority, shall have available both regular unleaded gasoline (87 octane) and diesel fuel. Is fuel being provided by the Port and stored by the Contractor or does the Contractor provide fuel and storage?
- A. Please see Section 33, entitled “Fueling” of Attachment B.
12. Can retail fuel stations be used as part of this contract and invoiced at actual cost to the Port Authority?
- A. Not at this time.
13. Please provide details on the radio system, including the frequency and airtime charges, if applicable.
- A. Please see Section 44, entitled “Radios and Other equipment” of Attachment B, and Exhibit 9.
14. Please confirm all facilities that will be made available during this contract term.
- A. Please see Section 45, entitled “Space Provided to the Contractor” of Attachment B.
15. Please provide further details on the wash system and location.
- A. See Changes/Modifications, III, above.
16. Please clarify the number of vehicles used in service by day of week, the peak service hours and the number of buses in service at these times. A chart would be preferred.
- A. Please see Changes/Modifications Item Number V above.
17. Does the Port have any requirements regarding support vehicles? Type, number, age limit, fuel type. How many are currently being supplied by the Contractor?
- A. Please see Exhibit 5, Personnel Fleet Requirements.
18. What is the required schedule for vehicle exterior cleaning?
- A. Please see Section 40, entitled “Personnel Transportation Services”, subparagraph B of Attachment B.
19. What are the current cleaning requirements for COVID-19?
- A. Please see Changes/Modifications, Item Number I above.
20. Please provide/confirm the vehicle miles; deadhead miles and hours; and total miles and hours for these services for the past 12 months.
- A. Please see Changes/Modifications Item Number VI above.
21. Please provide the average number of revenue hours for each day of the week.

- A. The number of revenue hours is the same each day, which is currently 200 hours per day; 176 hours are on the P6 route while an additional 24 hours relate to emergency and other non-route services.
22. Please provide the average revenue miles for each day of the week.
- A. Miles traveled depends on service levels. Current service includes approximately 1,500 – 2,000 daily miles.
23. For daily service, please clarify if billable time continues past scheduled hours on the last trip due to external factors (traffic, weather, incidents, etc.).
- A. Hours beyond prior scheduled hours are not billable without prior written approval from the Manager.
24. We intend to hire as many of the existing employees as possible. In order for us to ensure that they make at least as much, or more than they do now, please provide a seniority list for the current employees for this contract, and indicate position, full time or part time, length of service, and current rate of pay.
- A. Information relating to the current contract does not necessarily reflect the particular scope of work for the contract to be awarded as a result of this solicitation. Accordingly, you should submit a proposal, including a mutually beneficial financial proposal, in response to the requirements of this solicitation.
25. What is the current starting wage for drivers and hourly staff positions?
- A. Information relating to the current contract does not necessarily reflect the particular scope of work for the contract to be awarded as a result of this solicitation. Accordingly, you should submit a proposal, including a mutually beneficial financial proposal, in response to the requirements of this solicitation.
26. What is the current benefit participation?
- A. The Port Authority does not have access to this information.
27. Do the current labor contract(s) include a pension plan? If so, please provide any details surrounding this plan. i.e. Defined Benefit, Defined Contribution, Under-funded liability.
- A. The Port Authority of New York and New Jersey does not have access to this information.
28. At various times, state, federal, and local governments change laws, rules and regulations which require a company to increase the wages or benefits for the employees that will be employed under this contract. If such an event occurs during the term of the agreement, how will the agency respond for a request for increased compensation. For example, the recent Affordable Care Act legislation significantly affected the level and cost of medical coverage for employees. Since these events cannot be anticipated and the costs are so significant, we need to understand the risk associated with such laws, rules or regulations.

- A. The current positions for the existing contract are the same as required for this RFP.
30. Please provide a current organization chart to include management, staff and drivers.
- A. This information will be provided to the awarded Contractor.
31. Please confirm required named personnel for proposal.
- A. Please see Section 5, entitled “Evaluation Criteria and Rankings” of Attachment B.
32. Please provide any required experience needed for named personnel.
- A. Please see Section 5, entitled “Evaluation Criteria and Rankings” and Section 37, entitled “Job Descriptions” both of Attachment B.
33. Please provide details regarding any DBE subcontractors being used in this service currently, and which services they are providing? Could a utilization report be provided?
- A. This information is not available.
34. Are all positions required to be 100% dedicated to this contract?
- A. Please see Section 37, entitled “Job Descriptions” of Attachment B.
35. What is the current pre-trip and post-trip time per driver?
- A. The current depot is approximately 30 minutes from the Airport.
36. Please provide the performance statistics of the current Contractor for the past 12 months for accidents (preventable and non-preventable), on-time performance, total operational complaints.
- A. This information is not available.
37. Who is the current provider and for how many years has the existing contractor held this contract including extensions?
- A. Academy Bus, LLC has held the contract since 2010.
38. Please provide copies of the last three months of management reports from the contractor.
- A. This information is not available.
39. Please provide a copy of the current contract for these services.
- A. A copy of the current contract is not currently available. You may submit a Public Records Access request via the website

<https://corpinfo.panynj.gov/pages/public-records-access-form/>. Additionally, you may search under “Fulfilled Requests” on the same page. However, information relating to the current contract does not necessarily reflect the particular scope of work for the contract to be awarded as a result of this solicitation.

40. What are 3 things that the Port would like to see improved in the current service?
 - A. This information is not available.
41. What are the top 3 complaints received by passengers on this service?
 - A. This information is not available.
42. Are there any changes in the liquidated damages for this new RFP from what is currently in place with the current contract?
 - A. Information relating to the current contract does not necessarily reflect the particular scope of work for the contract to be awarded as a result of this solicitation.
43. Would the Port consider postponing performance liquidated damages during the first 90 days of the new contract period for a new contractor?
 - A. No.
44. What is the required number of training hours for new drivers? Please also identify any other required training.
 - A. Please see Section 42, entitled “Training by the Contractor” of Attachment B.
45. During the transition, how many vehicles will be made available to the incoming Contractor to perform training?
 - A. All vehicles not in service at the time of training will be provided.
46. During the transition, will there be space available at the facility to conduct start up activities?
 - A. The RFP states the PA will provide office space, however the PA would consider making additional facility space available for start-up, depending on the request.
47. Due to the complex business environment with Covid-19 and the short timeline between the questions being answered and the due date, could the due date be extended until the first week of January?
 - A. Any extension will be issued via an addendum and posted to our website at www.panynj.gov.
48. Please provide current staffing schedule for each job classification.
 - A. Please see Section 37, entitled “Job Descriptions” of Attachment B.
49. Please provide a list of technologies that are currently used on the buses (i.e. to track passenger usage, GPS, camera, etc.).
 - A. Please see Section 30, entitled “Bus Equipment” of Attachment B.

50. The pricing sheet does not allocate pricing for Contingency service for EWR. Is that correct?
- A. Contingency service is included in the total hours on the pricing sheet.
51. Is there a different rate for Contingency service required on less than 2 hours notification?
- A. No.
52. Are there any existing warranties in place for the major components of the Hybrid System, (i.e. Traction Motor, Generator and PCS)? Is the contractor responsible for replacing these items at our cost?
- A. Please see Changes/Modifications, item VII, above.
53. With ongoing construction, will the contractor still be required to cover the expense of body damage to the fleet? If so, can you provide an estimate of the current cost of body work being experienced?
- A. Please see Section 30, entitled "Bus Equipment" of Attachment B.
54. Vehicle Maintenance does not reference that these vehicles are to be NJDOT inspected. Please confirm if the current fleet requires DOT inspection.
- A. Please see Section 31, entitled "Vehicle Maintenance" of Attachment B.
55. The RFP references the ability or requirement to provide a Mid-Life Overhaul Program. Which buses in the current fleet does the Port Authority anticipate needing to be overhauled during the term of the contract?
- A. The hybrid buses were refurbished in early 2020. While the Port Authority does not currently have a plan to re-life any of the existing buses, the only buses that would be candidates for the mid-life overhaul would be the diesel buses.
56. Does the contractor get reimbursed/paid for keeping drivers on standby in the event an AirTrain outage requires emergency service?
- A. The contractor gets reimbursed for any time the Port Authority requests to have drivers on standby.
57. Please provide the current monthly billing template.
- A. The billing template mirrors the pricing sheets in Exhibit 2A of the RFP.
58. Does the Port have a Fleet Management Plan that indicates when they expect to replace each bus, and what type of bus they expect to replace it with? If so, can we get that information?
- A. There is no Fleet Management Plan or set schedule to replace buses at this time.
59. As stated on Page 62 Section 37 of the RFP, Job Description supervisory staff consists of operations dispatcher, Road Supervisor, Field Supervisor, (Herein

Collectively Called Field Supervisors). Page 124 Exhibit 2c shows Dispatcher is included under the Management Fee. Please clarify if the operations dispatch and the dispatcher under the management fee are two different positions or one position under two descriptions.

A. Please see Section 37, entitled “Job Descriptions” of Attachment B.

60. As stated on page 62 last paragraph from 8am to 5pm physical presence of supervisors is required, does this express a dispatcher will not be needed after 5pm as well?

A. Please see Changes/Modification, item II, above.

61. In regard to the expected 3% SDVOB participation level, since the Port Authority directory has a limited amount of certified SDVOB firms, would an NYS OGS certification be acceptable? If not, will the Port Authority assist in expediting the certification process for qualified SDVOBs?

A. This is a good faith goal and the Port Authority’s Office of Diversity & Inclusion will assist in the certification process for any new requests.

62. Will fuel/gasoline for the buses be provided by the PANYNJ or is that an area of opportunity for MWBE/SDVOB participation?

A. Fuel is not provided by the Port Authority.

63. The MWBE goals are 30% total, but broken down into 20%MBE/10%WBE, is a waiver required if the Contractor comes in at another variation but still hits the total 30%? For example, 15%MBE/15%WBE or 10%MBE/20%WBE?

A. These are good faith goals.

64. Can the maintenance records be made available to view?

A. No.

65. What if any are the reasons for long term out of service (OOS) vehicles?

A. Buses can be out of service for a number of reasons, not limited to: mechanical issues, damage due to accidents, recalls, warranty repairs, etc.

66. If the vehicles are part of a mid-life overhaul program who is responsible for the cost?

A. Please see Section 19, entitled “Refurbishment of Buses” of Attachment B.

67. Who is responsible for the major mechanical components i.e. ACTM ACTG PCS Orion hybrids & Proterra?

A. Please see Section 1, entitled “General Agreement” of Attachment B.

68. Are the vehicles available for an inspection?
- A. See Addendum # 2.
69. Are the vehicles part of any extended warranty programs currently if so, what are they and when do they expire?
- A. Please see Changes/Modifications, item VII, above.
70. Who is responsible for the cost of ESS (Energy Storage System) overhaul and replacement Hybrid vehicles?
- A. Please see Section 19, entitled "Refurbishment of Buses" of Attachment B.
71. Who is responsible for the electric Battery replacements for the Proterra buses?
- A. Please see Section 47, entitled "Bus Battery Replacement" of Attachment B.
72. Who is responsible for existing vehicle conditions if they are not suitable for operation?
- A. The contract requires the operator to return all vehicles in good operating order and condition, other than normal wear and tear.
73. Being that there is not a shop facility provided in the contract will the Port Authority be willing to share in the cost of a facility?
- A. No.
74. Is there a current employee training manual in existence that we can review?
- A. No
75. Can the locker room and staging area be more defined as to where it is? How much room do we have to stage buses on the property? How large is the locker room area? Is there a driver breakroom?
- A. The sole areas dedicated to the Contractor is office space as outlined in Section 45, entitled "Space Provided to the Contractor" of Attachment B, as well as the on-airport bus charging area (which can accommodate six buses charging) and Terminal B/ C bus courtyards (a maximum of additional four spaces in total). At this time, there is not a breakroom or locker room provided for the drivers.
76. Can the field dispatcher also serve as the dispatcher?
- A. Please see Section 37, "Job Descriptions" of Attachment B.
77. Regarding the two vans transporting employees, who is supposed to drive the vehicles? Can a dispatcher drive the vehicle when needed or should we staff a

driver position for the vehicles? Can the supervisor or the dispatcher drive the car and use that as their workstation or do they need to be posted someplace?

A. Any staff dedicated to the Contract can use the vehicle. It would be expected that the Operations Manager or Field Supervisor would be driving those support vehicles as part of their daily duties.

78. Who are the current subcontractors operating in the contract? What is their minority status? WBE, MBE, and SDVOB?

A. This information is not available.

79. Can you please define how often and the jobs that are performed on airside? Will the vehicles be escorted airside? Is there additional training for drivers to be able to drive on airside?

A. Airside bus requirements include both planned and unplanned services. Planned services consist of airport Driver Training (once per week, approx. two hours) as well as on occasion tours. Unplanned airside needs are infrequent and may be a result of aircraft emergencies and inclement weather. Historically, unplanned needs are typically dispatched for up to 30 minutes, two or three times per week. Drivers will not require extra training as they will be under constant escort.

80. The current schedule appears to be 176 hours per day which is approximately 64,240 hours per year. What is included in the 150,896 hours?

A. Please see Changes/Modifications, item IV, above.

81. In Exhibit 6, are you wanting us to get to 12 buses or 20 buses during peak periods? Can you elaborate more on the required escalation of buses?

A. A bare minimum of 12 buses would fulfill a combination of reduced P6 service as well as base AirTrain alternate transportation (bus bridge) service. It would be our goal to fulfill up to 20 buses during an AirTrain outage as a means to provide optimal headways.

82. When looking at the directory, many suppliers are listed solely as DBE or SBE. Can working with them be applied to the MBE, WBE, SDVOB goals?

A. In order to be applied to the MBE, WBE, and SDVOB goals the firm must be certified as such with the Port Authority of NY & NJ. All SBEs are not MBE, WBE, or SDVOB certified.

83. With regard to the refurbishment and conversion of buses to electric buses, we understand the expense is to be a passthrough to the Port Authority, however, it will take some management to ensure the process is completed to the standards of the Port Authority. Can the additional management expense also be passed along to the Port Authority?

A. No.

84. Do the buses come with cameras on the outside in the front, rear, left and right side of the bus as well as inside the bus including the driver cabin area and passenger area? If so, is the footage available to the shuttle provider on demand?
- A. The existing buses have an installed camera system inside the bus which provides limited video capacity. The Contractor can work with the existing operator for the purchase and continued use of this equipment, or it can arrange to install their own camera system on the buses.
85. Do they have cameras at the staging lot?
- A. No.
86. Where does the general liability, auto and workman's comp insurance get inserted into the expense formula on the pricing page? Is it part of the management fee?
- A. It is a business decision of the Respondent on how to amortize the costs of required insurance.
87. We understand the health insurance is to be paid by the employer. Can alternative plans be offered to employees that might provide superior health coverage but require an employee contribution as long as it doesn't change the overall cost of the operation?
- A. No employee contributions to the healthcare premium are permitted.
88. Are the current transit employees covered by 49 USC 5333(b) (also known as Section 13c of the Urban Mass Transportation Act of 1964)?
- A. The Contractor is responsible for following all applicable local, state, and federal laws, rules, and regulations.

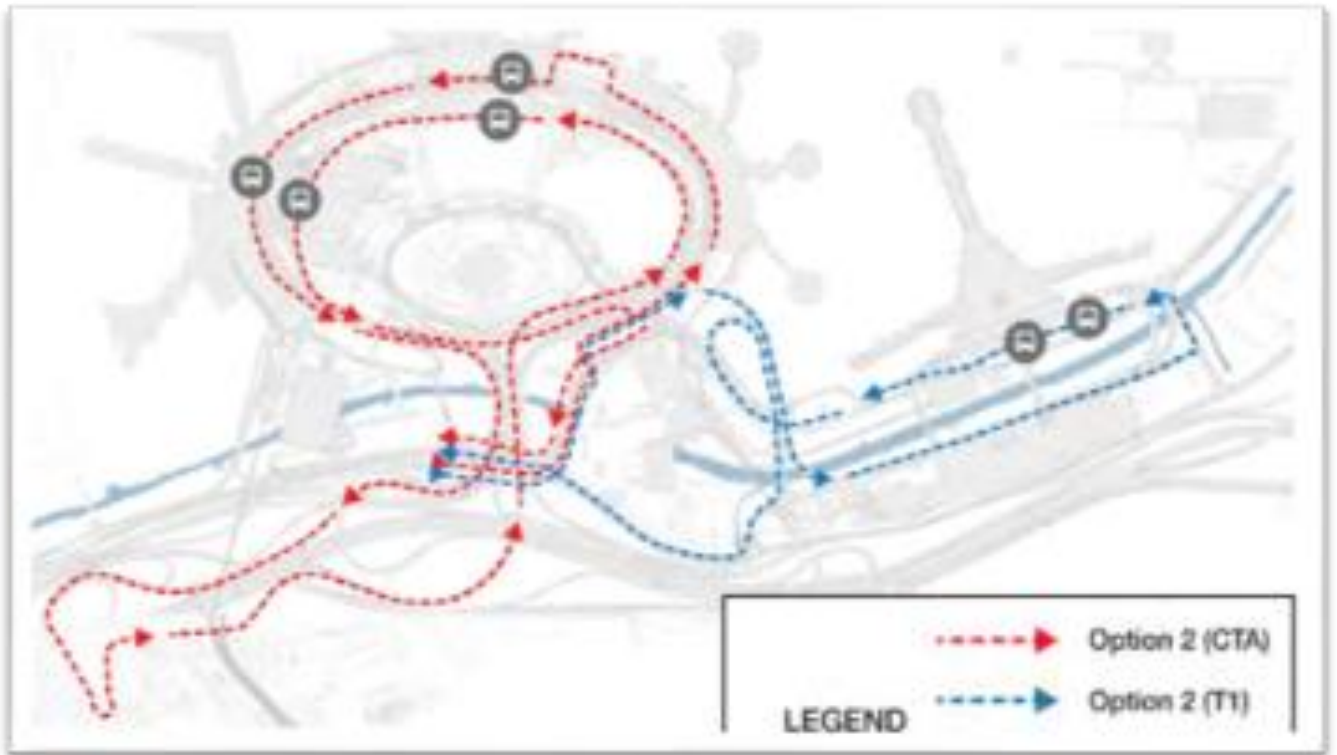
